### MINUTES OF THE NOVEMBER 9, 2020 REGULAR MEETING OF THE HOUSING AUTHORITY OF THE TOWN OF PHILLIPSBURG

A Meeting of the Housing Authority of the Town of Phillipsburg was held on November 9, 2020 at 6:00 P.M., via telephone conference pursuant to the New Jersey Open Public Meetings Act, N.J.S.A. 10:4-6 et seq.

The meeting was called to order by Chairperson John Korp at 6:00P.M. and upon roll call the following members were present: Commissioners: Korp, Shelly, Swick, Baptista, Corcoran, & Van Why. Also present was Executive Director Paul Rummerfield and General Counsel, Katharine Fina, Esq.

Chairperson Korp announced in accordance with the Open Public Meetings Act, notice of the meeting was delivered to the Express-Times, Municipal Clerk, posted in the Municipal Building, posted in the Housing Authority Office and on the website. Chairperson Korp directed said announcement to be entered in the minutes of the meeting.

**ACCEPTANCE OF THE MINUTES** OF THE REGULAR MEETING OF OCTOBER 7, 2020 *Commissioner Corcoran* moved to approve the minutes, which motion was seconded by *Commissioner Van Why*. Chairman Korp advised that he voted "no" on Resolution No. 1789 and requested that the minutes be changed to reflect as such. With this change, the Minutes were unanimously accepted.

ACCEPTANCE OF THE MINUTES OF THE EXECUTIVE SESSION OF OCTOBER 7, 2020 Commissioner Corcoran moved to approve the minutes, which motion was seconded by Commissioner Swick. Minutes were unanimously accepted.
