#### **NEW BUSINESS**

# RESOLUTION #1757 - APPROVAL OF FEE ACCOUNTANT SERVICES TO "WILLIAM KATCHEN, CPA"

BE IT RESOLVED, the Board of Commissioners of the Housing Authority of the Town of Phillipsburg hereby awards the Proposal for Fee Accounting Services to "William Katchen" at the rate of \$3,000 per month for the period of 7/1/2020 to 6/30/2021. Second year option is for the same price. *Commissioner Baptista* moved to adopt Resolution #1757, which motion was seconded by *Commissioner Franceschino*. All were in favor of this motion.

## <u>RESOLUTION #1758 – APPROVAL OF TENANT/LANDLORD LEGAL SERVICES TO</u> JOHN CALECA III, ESQ.

**BE IT RESOLVED**, the Board of Commissioners of the Housing Authority of the Town of Phillipsburg hereby accepts the recommendation of the Executive Director for the following amounts to be written-off accounts of the Housing Authority totaling \$101,634.98.

# RESOLUTION #1762 – APPROVAL OF WRITE-OFFS FOR JUNE 2020 FOR AMP II

**BE IT RESOLVED,** the Board of Commissioners of the Housing Authority of the Town of Phillipsburg hereby accepts the recommendation of the Executive Director for the following amounts to be written-off accounts of the Housing Authority totaling \$7,661.82.

Commissioner Franceschino moved to adopt Resolution #1628, which motion was seconded by Commissioner Baptista. All were in favor of this motion.

# RESOLUTION #1763 – AUTHORIZATION TO REJECT ALL BIDS FOR CEILING FANS AT THE HECKMAN HOUSE & JOHN F. O'DONNELL BUILDINGS AND TO READVERTISE THE JOB

**BE IT RESOLVED**, the Board of Commissioners of the Housing Authority of the Town of Phillipsburg hereby rejects all bids for ceiling fans at the Heckman House and John F. O'Donnell buildings and to re-advertise the job. *Commissioner Shelly* moved to adopt Resolution #1763, which motion was seconded by *Commissioner Franceschino*. All were in favor of this motion.

# RESOLUTION #1764 - TERMINATION OF NEWTON HA SHARED SERVICE AGREEMENT EFFECTIVE JANUARY 1, 2021

BE IT RESOLVED, the Board of Commissioners of the Housing Authority of the Town of Phillipsburg hereby rejects the proposed Shared Services Agreement between the Phillipsburg Housing Authority and Newton Housing Authority; and will cease providing managerial services to the Newton Housing Authority as of December 31, 2020, for the purpose of providing a transition period.

Commissioner Decker moved to adopt Resolution #1764, which motion was seconded by Commissioner Swick. Commissioners Corcoran, Swick, Decker, and Korp were in favor. Commissioners Franceschino, Baptista, Shelly were opposed.
