### MINUTES OF THE MAY 5, 2021 REGULAR MEETING OF THE HOUSING AUTHORITY OF THE TOWN OF PHILLIPSBURG

A Meeting of the Housing Authority of the Town of Phillipsburg was held on May 5, 2021 at 6:00 P.M., via telephone conference pursuant to the New Jersey Open Public Meetings Act, N.J.S.A. 10:4-6 et seq.

The meeting was called to order by Chairman Korp at 6:00P.M. and upon roll call the following members were present: Commissioners: Shelly, Corcoran, Van Why, Hay, Scerbo, and Pierce. Also present were Acting Executive Director Tom McGuire and General Counsel, Katharine Fina, Esq.

Chairman Korp announced in accordance with the Open Public Meetings Act, notice of the meeting was delivered to the Express-Times, Municipal Clerk, posted in the Municipal Building, posted in the Housing Authority Office and on the website. Chairman Korp directed said announcement to be entered in the minutes of the meeting.

**ACCEPTANCE OF THE MINUTES** OF THE REGULAR MEETING OF APRIL 7, 2021 *Commissioner Shelly* moved to approve the minutes, which motion was seconded by *Commissioner Van Why*. The minutes were accepted by a vote of 5-0-2 with Chairman Korp and Commissioner Hay abstaining.

**ACCEPTANCE OF THE MINUTES** OF THE EXECUTIVE MEETING OF APRIL 7, 2021 *Commissioner Corcoran* moved to approve the minutes, which motion was seconded by *Commissioner Scerbo*. Minutes were accepted by a vote of 5-0-2 with Chairman Korp and Commissioner Hay abstaining.

**BE IT RESOLVED,** the Board of Commissioners of the Housing Authority of the Town of Phillipsburg hereby authorize Chairman John Korp to execute the Certification of Compliance with PHA Plan and Related Regulations.

Commissioner Pierce moved to adopt Resolution #1842, which motion was seconded by Commissioner Scerbo. All were in favor of this motion.

## RESOLUTION #1843 - ADOPTION OF ANNUAL AND CAPITAL BUDGET FOR FISCAL YEAR BEGINNING JULY 1, 2021 AND ENDING JUNE 30, 2022

**BE IT RESOLVED,** the Board of Commissioners of the Housing Authority of the Town of Phillipsburg, at an open public meeting held on May 5, 2021; the Annual Budget and the Capital Budget/Program of the Housing Authority for the Fiscal Year beginning 7/1/2021 and ending 6/30/2022; hereby Adopted and shall constitute appropriations for the purposes stated; and that the Annual Budget and Capital Budget/Program as presented for Adoption reflects each item of revenue and appropriation in the same amount and title as set forth in the introduced and Approved Budget, including all amendments thereto, if any, which have been approved by the Director of Local Government Services.

*Commissioner Corcoran* moved to adopt Resolution #1843, which motion was seconded by *Commissioner Hay*. All were in favor of this motion.

## RESOLUTION #1844 – APPROVAL TO SUBSIZE FIRTH YOUTH CENTER REGISTRATION FEES FOR CHILDREN WHO RESIDE IN THE PHILLIPSBURG HOUSING AUTHORITY

**BE IT RESOLVED,** the Board of Commissioners of the Housing Authority of the Town of Phillipsburg hereby approves to subsidize the Firth Youth Center Registration Fees for the children up to eighteen (18) years of age or seniors in high school who reside in the Phillipsburg Housing Authority.
